Game Day Volunteer Obligation: It is required that each player's family work 3 game day service events (concessions, gates, etc.). Players or any family member age 15 or older may fulfill this obligation. Sign-up sheets will be available at the parent meeting tentatively scheduled for the beginning of January or you may contact your team parent.

Fundraising Obligation: Each player is required to participate in all **PLA Program-level** Fundraising.

Fundraising OPT-Out: You may pay an **additional \$200 per player at the time of registration** if you wish not to participate in PLA Program-level fundraising. You are still obligated to volunteer for required game day events as described above (see section Game Day Volunteer Obligation).

Eligibility: Assessments will be made during the season to determine whether volunteer/fundraising obligations are being met. For obligations not being met you will be notified, player members will become ineligible to participate beginning **May 1st** and will be ineligible for year end awards/league recognitions.

**For use of PLA Equipment/Uniforms Only (Helmets, Goalie equipment and Uniforms)
EQUIPMENT/UNIFORM USAGE AGREEMENT AND WAIVER OF LIABILITY**

The Pickerington Lacrosse Association (PLA) agrees to provide participants with equipment (e.g., helmet, shoulder pads, goalie equipment) and uniforms for use during the 2013 spring lacrosse season. The Participant and Parent or legal guardian of participant agree to the following:

1. The Participant shall not to misuse, abuse, or cause damage through negligence to the equipment or uniforms.
2. The Participant & Parent shall perform necessary maintenance, and keep the equipment and uniforms clean and in good repair.
3. The Participant & Parent acknowledge that if the equipment or uniform is found to have been damaged or not kept in good repair, the Program reserves the right to revoke the use of equipment or uniform and the participant's registration fee will not be refunded.
4. The Participant & Parent acknowledge that if the equipment or uniform is lost, stolen, or damaged, the Participant/Parent shall be responsible for the repair or replacement cost. Failure to submit payment for repair/replacement shall result in the Participant being ineligible to play.
5. The Participant & Parent acknowledge, agree, and represent that they understand the nature of lacrosse and the Participant is qualified, in good health, and in proper physical condition to participate in the Activity. The Participant & Parent further agree and warrant that if at any time they believe conditions to be unsafe, the Participant shall immediately discontinue further participation in the Activity.
6. The Parents hereby acknowledge that lacrosse is a contact sport that involves risks and dangers of serious bodily injury, including permanent disability, paralysis, and death. These risks may be caused by the Participant's own actions or inactions, the actions or inactions of other participants, the condition in which the Activity takes place, or the NEGLIGENCE OF THE "RELEASES" NAMED BELOW; there may be OTHER RISK AND SOCIAL AND ECONOMIC LOSSES either known or not readily foreseeable at this time; and FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES incurred as a result of participation in the Activity.
7. The Parents hereby release, discharge, and covenant not to sue the Pickerington Lacrosse Association, Pickerington Local School District, representatives (board members, coaches, volunteers, or parent representatives of any kind) of said organizations, other participants/players, sponsors, advertisers, or owners/lessors of premises on which the Activity takes place (each one the "releases" herein) from ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR "RELEASES" OR OTHERWISE. And further agree that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT, the Participant/Parent makes a claim against any of the releases, the releases will be indemnified, and held harmless from any litigation expenses, attorney fees, loss, liability, damage, or cost which may incur as the result of such claim.
8. **I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT FREELY AND WITHOUT INDUCEMENT OR ASSURANCE OF ANY NATURE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID, THE BALANCE, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT.**
